FOUNDED IN 1992, THE FESTIVAL IS THE CENTERPIECE OF THE FILM SOCIETY'S PROGRAMMING, CELEBRATING THE BEST OF FILM FROM AROUND THE WORLD. CONSISTING OF OVER 200 SCREENINGS, OF MORE THAN 140 DOMESTIC AND INTERNATIONAL NARRATIVES, DOCUMENTARY AND SHORT FILMS, THE 2015 FESTIVAL ATTRACTED NEARLY 25,000 ATTENDEES WITH A RECORD NUMBER OF ALL-ACCESS BADGES SOLD AS WELL AS MORE THAN 10,000 COMPLIMENTARY TICKETS CLAIMED VIA THE PFF ON US FREE TICKETING PROGRAM. LIKEWISE, THROUGH THE STUDENT SCREENING PROGRAM, MORE THAN 1,500 STUDENTS ATTENDED SCREENINGS AT THE FESTIVAL, WITH ENGAGING DISCUSSION FOLLOWING FILMS.
