FEATURING THE LARGEST SCREEN IN THE CITY, THE PHILADELPHIA FILM CENTER HOSTS FILM EVENTS IN TWO STATE-OF-THE-ART THEATERS.

FOUNDED IN 1992 AS A WORLD-CLASS FILM FESTIVAL, PFF IS THE CENTERPIECE OF PFS'S ANNUAL PROGRAMMING, CELEBRATING THE BEST OF THE FILM FROM AROUND THE WORLD. CONSISTING OF NEARLY 200 SCREENINGS, THE 2018 FESTIVAL ATTRACTED NEARLY 25,000 ATTENDEES WITH A RECORD NUMBER OF ALL-ACCESS BADGES SOLD.
